Government Audits

The Office of Civil Rights of the Department of Health and Human Services has announced a new phase of HIPAA Audits

- OCR may contact you for information as it creates a pool of candidates for audit
- If selected for a "desk audit," you will need to quickly provide documentation of compliance with selected HIPAA requirements
- OCR will target certain entities for more comprehensive on-site audits
- Substantial compliance issues could lead to an investigation and significant penalties

Cyber Threats

Health information has become a particular target of criminal activity

- Health information is considered to be 20 to 50 times more valuable on the black market than ordinary financial information
- The information systems of sophisticated health benefit insurers and administrators have been breached, affecting millions of plan participants
- Ransomware and other potentially devastating threats to information systems continue to emerge

Actions Needed

Employer-sponsored health plans, health care providers, and business associates should be taking measures now

- The OCR audit program requires fast turnaround; you will need to be prepared in advance
- OCR may ask for documentation that demonstrates recent efforts to meet ongoing requirements
- Because of evolving threats to the security of electronic information, HIPAA requires periodic assessments of security measures
